

The client needed 50,000 charts coded with HCC and project-specific guidelines for the development of an Al coding tool. In the initial stage, 2,000 charts had to be coded twice simultaneously for an 80% match rate, followed by coding the remaining charts using the guidelines. To ensure success, we handpicked a team of 25 coders based on their performance and alignment with client requirements. The Team Lead/Project Manager audited 5% of the coded charts and provided personalized coaching to maintain accuracy. We implemented regular monitoring and auditing of chart accuracy, checking 1-5% of the total volume.







Faced with a recent rebranding, our client set their sights on reaching a membership of over 5,000 by the end of 2024. As a result, they required reliable and timely Risk Adjustment solutions. To meet this challenge, we conducted thorough chart and data reviews, while also providing essential education to address coding gaps among providers. Over a two-week period, we worked closely with the client's executives, IT team, and Provider Engagement contacts to seamlessly begin and complete all phases of the project. This involved integrating a secured FTP and ensuring our coders received the necessary training through a strategic partnership with Cavo.

As a result, we successfully reviewed over 500 encounters within the required timeframe. We identified 289 new codes, validated 172 existing codes, and identified 35 codes lacking proper documentation. Furthering our commitment to excellence, we also recognized 82 opportunities for education and conducted informative webinars with providers to address these gaps. Ultimately, we delivered a comprehensive report to the company well before their deadline, granting them ample time to submit the necessary documents through their trusted Third-Party Administrator (TPA).


